The Street Medicine includes a component called Companion Care where volunteers accompany and advocate for our vulnerable patients to follow up appointments for serious medical conditions.

Women's Free Homeless Clinic occurs three times per month that addresses the special needs of women who live on the streets. We provide showers, laundry, a hot meal and use of a fully staffed medical clinic.
